REPRESENTING YOURSELF

When you represent yourself in a lawsuit, you are considered to be acting "pro se" and as such you will be acting as your own attorney. Representing yourself comes with the responsibility of educating yourself. You will need to educate yourself on the "substantive law" which is the law governing the core of your dispute before the court.



There are several layers of court systems. Municipal courts have limited jurisdiction and largely hear cases involving violations of local city laws or ordinances. The Law Library has a "Guide to Representing Yourself in Municipal Court" in its catalog (<u>https://stllawlib.bywatersolutions.com/</u>). State courts have a broader jurisdiction addressing issues that involve the interpretation of state laws. The federal court system has jurisdiction over cases involving federal laws or the U.S. Constitution, or where the U.S. is a party.

You will also be expected to know and follow procedural law and the rules of the court. Therefore, at a minimum, if you will appear in a Missouri State court you should review the Missouri Rules of Civil Procedure and the local court rules. For example, if your case is in the City of St. Louis, you would review the Twenty-Second Judicial Circuit Court Local Rules. Failing to follow the rules of court may result in a loss of important rights in your court case.

All of your requests to the court should be made in a written motion filed with the court. You must send a copy of every motion or pleading that you file to the opposing attorney, or to the opposing party, if they are not represented.

You cannot seek legal advice from court staff. Neither the judge, opposing counsel, nor any courtroom staff (including the court clerk) can give you legal advice. The staff in the Clerk's Office, as well as the judge's own courtroom clerk, may be able to assist you with questions about courtroom procedure and rules.

You can find court personnel through the Office of State Court Administrator's website (https://www.courts.mo.gov/#findacourt) and they can help you with non-legal information.

You are not allowed to have "ex parte" communication with the judge. This means you may only communicate with the judge when all parties and/or their attorneys, if represented, are present. You may not try to communicate with the judge privately in any form (this includes emails, phone calls, voicemails, letters, or in-person conversations).

The clerk of the court will notify you by mail of hearings and filings by the other parties to the case. Therefore, you must provide the Court with a reliable mailing address and phone number. If you move without updating your address with the court, you may not get notice of filings or hearings, which could result in the loss of important rights in your case.

Upon receiving a notice of a scheduled hearing or trial, you must be ready to present your evidence and witnesses in person on that scheduled date. At the hearing or trial, each party will have a chance to tell the judge their side of the issue before the court. You need to bring your paperwork and evidence (including photos, witnesses, bills, receipts, contracts, etc.) that will prove your case. If you fail to appear, the judge could decide the case without you.

In certain types of cases, you or the opposing party may be entitled to request a jury trial. Even where eligible for a jury trial, you may need to request a trial by jury in writing in advance of the trial date. If your case goes to trial by jury, you will have to go through the process of selecting jurors. This process is called "voir dire." The purpose of voir dire is to make sure that no member of the jury has a bias that could jeopardize the outcome of the case. You will have an opportunity to challenge potential jurors who may have a bias during the voir dire process.

In preparation for your hearing or trial, you can attend court and watch other cases. This will allow you to see how the judge runs the courtroom, where all of the parties sit, and the order of the trial. Plan to do this several weeks before your court date. Create a trial folder to keep yourself organized. It should include things like pleadings, evidence, applicable law, and an outline of your case for your trial.

Day of Trial Tips

How to dress: Dressing professionally shows respect for the legal process and the judge. Therefore, dress neatly and cleanly, as if you were going to a job interview. Please do not wear casual clothing, such as shorts, tank tops, sandals, or hats. A judge can remove you from the courtroom for inappropriate dress which could result in a default or dismissal of your case.

Courthouse Security: Be aware that most courthouses in the state of Missouri have security guards and security procedures when you enter the building. Do not bring any weapons or sharp objects that could be used as weapons as they will be taken away from you before you can enter the building.

Timeliness: Plan to arrive at the courthouse early, at least 30 minutes ahead of time, to allow for time to find and pay for parking, go through security, and locate the correct courtroom. Your witnesses also need to be on time.

Behavior in the Courtroom:

- Be respectful of all parties in the courtroom, and do not interrupt anyone in the courtroom (this includes the judge, the attorneys, the opposing parties, or any of the courtroom staff).
- Stand up when speaking to the judge and call the judge "Your Honor."
- Stay calm and speak clearly and loudly enough to be heard by the judge.
- Do not speak with others in the courtroom audience while the court is in session.
- Turn off your cell phone or any other audible devices while you are in the courtroom.
- Enter and leave the courtroom quietly.
- Do not eat, drink, or chew gum or tobacco.
- Do not bring children to court unless they have been subpoenaed.

Behavior violating any of the above guidelines could result in the loss of rights in your court case and the judge could file sanctions against you.

• Entrepreneurship Clinic: The clinic handles a wide variety of matters for start-up and small businesses and non-profit organizations focusing on business/transactional matters, including forming business entities and assisting with tax structure, drafting documents governing the organization's operations, and drafting and negotiating commercial agreements. The clinic only accepts clients if they cannot otherwise afford legal representation using available sources of funding (e.g., personal incomes, organizational revenue, investor contributions, etc.). - Low-Income Taxpayer Clinic: This clinic (LITC) helps low-income members of the community resolve their tax disputes with the IRS. All of its services (except filing fees) are completely free of charge. Clinic law students work under the supervision of two experienced tax lawyers to advocate for clients before the IRS. The clinic can help clients respond to IRS audits, including audits of the Child Tax Credit and Earned Income Tax Credits, file petitions with the U.S. Tax Court, request currently-not-collectable ("CNC") status when clients cannot pay what they owe, prepare an Offer in Compromise ("OIC") to settle debt, and submit an audit reconsideration. The Low Income Taxpayer Clinic does not assist clients with filing tax returns. To qualify for services, your income must fall within certain income limits (depending on household size) and the amount you owe the IRS must be less than \$50,000 for any given tax year.
