

#### REMARKS FROM THE LIBRARY DIRECTOR

As we close out the year 2024, the Law Library has a lot to be proud of. We continue to offer popular presentations, to host exhibits and to provide needed programs and resources to our diverse patron base. Our outreach to the general community continues.

#### Some accomplishments of 2024 include:

- Our Legally Reading book discussion group continues to be popular and attract new members. Holding these discussions remotely had led to participation by those from all corners of the St. Louis region and beyond.
- The Law Library entered into an agreement to work closely on projects with the Freedom Suits Memorial Foundation. Our first collaboration was a Juneteenth event that includes a showing of the film, "The Milly Project." This sold-out event was extremely well-received.
- Our fall joint exhibits, Slavery in St. Louis and The Freedom Suits, were extremely popular and well-received. There was widespread media coverage of these exhibits, including stories from KWMU (Saint Louis Public Radio), St. Louis American, KSDK Channel 5, Saint Louis Magazine and Nine PBS. The library hosted three large events during the run of the exhibits. In addition, smaller groups and individuals also came to see these groundbreaking exhibits.
- There are now 26 interview highlights of retired judges and jurists up on the Judicial Legacy Page of the library website.
- The Law Library published its new Pro Se Guide, "A Guide to Representing Yourself in Court" in late February. This highly praised guide is available at multiple locations in the region. Over 100 hard copies have been taken and more downloaded from our website and other community websites.
- The Library Director reached close to 100 people through her presentations throughout the region of the program, "Legal Research for the Non-Lawyer."
- The Library Director was recognized with the "Pro Bono Champion" award from the Bar Association of Metropolitan St. Louis for her work and the work of the library in supporting pro bono commitment and for efforts to reduce the access to justice gap
- The Law Library maintained almost all of the new large and median sized law firms who joined in 2023. In addition, the Law Library's end-of-year direct mail fundraising campaign continues to be very successful. The Library also has obtained exhibit sponsorships from new sources this year.

I look forward to continuing to serve the Law Library Association. We successfully are meeting the challenges and opportunities of this time and providing high level services and resources to members of the Bench, Bar and general public.
