

REMARKS FROM THE LIBRARY DIRECTOR

As we close out the year 2025, the Law Library has a lot to be proud of. We continue to offer popular presentations, to host exhibits and to provide needed programs and resources to our diverse patron base. Our outreach to the general community continues.

Some accomplishments of 2025 include:

- Our fall exhibit, The Judicial Legacy Project Exhibit, opened in September with a wellattended and well-received opening event. The exhibit also was profiled in a story on KWMU, St. Louis Public Radio, and in several other media outlets. It continues through March of 2026. Additional programs and group tours of the exhibit are taking place.
- Thanks to a donor connected to our partner organization, the Freedom Suits Memorial Foundation, the Freedom Suits Exhibit (created as a temporary exhibit for the Law Library in the fall of 2024) is now a permanent exhibit at the Law Library. Group and individual visits to this exhibit are continuing.
- There are now 31 interview highlights of retired judges and jurists up on the Judicial Legacy Page of the library website.
- The Law Library's Pro Se Guide, "A Guide to Representing Yourself in Court" continues to be very popular, both for patrons at this library and area public libraries in the region.
 Recently, the Law Library received a grant to translate this guide and several other selfhelp resources into Spanish. The Spanish language guides will be available at our library, downloadable from our website and provided to area public libraries and social services agencies.
- The Law Library continues to deepen and expand its partnerships. This year, the Law Library was asked to host two popular programs sponsored by the Bar Association of Metropolitan St. Louis (BAMSL). These were The Welcome to the Bar event for newly admitted lawyers and a CLE on Motion Practice, part of a new Practical Skills series organized by BAMSL and the St. Louis County Bar Association. The Legally Reading Book Discussion Group, a successful partnership with the Saint Louis Public Library, recently completed its seventh year.
- The Law Library maintained all of the large and median sized law firms who joined in 2023. In addition, the Law Library's end-of-year direct mail fundraising campaign continues to be very successful. We exceeded our fundraising goal this fiscal year. The Library also has obtained exhibit sponsorships from new sources this year, including from several large Missouri law firms.

I am honored to serve the Law Library Association. We are meeting the challenges and opportunities of this time and continuing to provide high level services and resources to members of the Bench, the Bar and the general public.
